

Privacy Notice (Vendor)

The **Data Controller** connected with this **Privacy Notice** is Barton Wyatt Ltd

1. Purpose

In this instance your data is being processed for the specific purpose of selling your property.

2. Lawful Basis

The collection of your data for this purpose is under the **Lawful Basis** of Contract, because we require this information in order to manage the sale of property.

3. Information Collected

The personal data we will collect and process about you in connection with this purpose is:

- 3.1. Name
- 3.2. Address (both for the property to be sold and for correspondence if they are different)
- 3.3. Telephone number(s)
- 3.4. Email Address
- 3.5. Proof of ID
- 3.6. Proof of Address
- 3.7. Company details (if the property is owned by a company)

In addition, we may collect other non-personal data regarding the property itself

4. Retention

Under the **Lawful Basis** referenced in paragraph 2, your data will be retained to the end of the financial year in which your property sale is completed and for a further 6 years thereafter in accordance with HMRC requirements for financial record keeping. Thereafter some details of the property will be retained indefinitely for historical record keeping purposes, to aid any future evaluation of the property, past sales activity and property values.

5. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

6. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 6.1. Photographic, Floorplan and Energy Performance Certificate providers may be engaged for this sole purpose of providing these services in the preparation of your property for marketing. Barton Wyatt uses a range of contractors for this. If we need to share your personal data with them to arrange access, we will make you aware of which company when we make the arrangements.
- 6.2. Rightmove and On The Market for the sole purpose of advertising your property.
- 6.3. The Buyer for the sole purpose of negotiating and managing the sale.
- 6.4. The Buyer's and Vendor's solicitors for the sole purpose of facilitating the sale. The details of these firms will be made known to you in the Memorandum of Sale, which will be issued to all parties at the point at which the

sale is agreed, subject to contract.

- 6.5. The other Agents in the “Chain” of sales / purchases associated with the sale for the sole purpose of managing the sale.
- 6.6. The Buyer’s Surveyor, for the sole purposes of arranging a survey of the property, should one be required and for the sole purpose of arranging access to the property.
- 6.7. Clarks Computer Systems Ltd, Jaijo Ltd, Amazon Web Services, Inc and In Touch Display Ltd for the sole purpose of providing and supporting the information technologies used by Barton Wyatt in the provision of its services.
- 6.8. The Property Ombudsman for the sole purpose of administering any investigation by them.

Where required, these data sharing activities are governed by commercial terms, which include data sharing clauses. These various data processors act under Barton Wyatt’s control and are only permitted to use the personal data for the sole purpose for which it is shared with them.

7. Rights of the Data Subject

- 7.1. Under the General Data Protection Regulation, you, the Data Subject have certain rights regarding the control and processing of your personal data. Details regarding your rights can be found on the Information Commissioner’s Office (ICO) [website](#).

8. Security

- 8.1. Recognising the importance of personal data to our consumers, we endeavour to put in place appropriate organisational and technical measures to protect that data. These are reviewed by an independent third party.
- 8.2. Personal data we hold on electronic media is stored in secured servers located in the EEA.
- 8.3. Where data is held on paper, access is controlled, and files are secured in secure cabinets in a secured office.
- 8.4. **Data Subjects** should be aware that not all electronic communications are secure. We use Transport Layer Security (TLS) to encrypt and protect email traffic in line with government advice. However, if your email service does not support TLS, you should be aware that any emails we send or receive may not be protected in transit.
- 8.5. We will also monitor any emails sent to us, including file attachments, for viruses or malicious software. Please be aware that you have a responsibility to ensure that any email you send is within the bounds of the law.

9. Additional Services

As a consumer of our services we may occasionally contact you to make you aware of other similar services we offer, which we feel could be of assistance to you. Such communications will be sent to you under the Privacy and Electronic Communications Regulations and you will be given the option to opt out of similar communications on each occasion.

10. Data Protection Concerns
